Mayor noted this clarifies and updates the Village's bidding and purchasing policies.

Schmidt noted that the new section refers a few times to "Finance Department", he would suggest that this reference be defined in the future.

6:37 PM Motion to approve the 2025/2026 Fiscal Year Budget: Revenues = \$16,785,495 / Expenses = \$14,868,030; Moved by Schmidt, Seconded by Clark.

Vallino applauded all for getting the Budget done this early. Also requested that the approval be postponed for 2 weeks until the 2 new Trustees are seated, so that they can have a "buy-in" in the decision.

Clark commended all for getting the budget done and the work involved.

Mayor responded to Vallino's request to postpone, noting that passing it now puts the budget on a schedule for the future. Feels the budget is appropriate and appreciates his opinion.

6:42 PM NEW BUSINESS / TRUSTEE COMMENTS

6:42 PM Vallino mentioned a complaint he had received regarding the men's bathroom at Pavilion 1 not being clean. Mayor stated he had investigated and found that the toilet overflowed. Vallino also received a complaint from a Stonebridge resident stating they consistently have low water pressure and a red film in the water. Mayor stated he was not aware of any issues. Requested that Vallino instruct the individual to contact Hoffmann, noting there is possibly a residential water filter issue.

6:46 PM Schmidt asked if there is an assessment of vehicles regarding hail damage. Mayor responded claims have been filed. Appraisals are still being done.

6:47 PM Kostyshock wished all a happy and safe Easter.

6:47 PM Clark reported the Discovery Series (Charcuterie Boards) went well noting 23 people had attended. Also wished all a Happy Easter.

6:47 PM White also wished everyone Happy Easter. White then discussed a bill in the Illinois House (HB 1237) that would ban the Collinsville School District's Kahok mascot. The bill bans all Native American mascots, titles, etc. in the State of Illinois. The bill has passed the House. White noted that Dr. Skertich sent out a plea for individuals to contact Senator Suzy Glowiak Hilton and state their opposition to this measure. Dr. Skertich noted that removing/changing the Collinsville Kahok would cost Unit 10 more than \$2 million. White will forward Dr. Skertich's email to everyone. Mayor noted he had sent a letter on behalf of the Village opposing the bill to the local Representatives in the area. He was also informed that Senator Erica Harriss is proposing an amendment that would leave the decision up to the local authorities. White asked all to please contact Senator Hilton as soon as possible.
