

**MARYVILLE PLANNING COMMISSION**

Public Hearing for Anderson Hospital 6800 State Rt 162 Maryville, IL 62062 opened at 6:01 PM. There were thirteen guests in attendance.

Anderson Hospital Representatives spoke on behalf of the property owners and discussed the project overview and needs for a variance. Parking supply has been observed to be within current capacity. Landscaping variance is also being asked to limit trees in line with the flight paths of the helicopter pad.

Public comments were received regarding the letter notice received in the mail.

No further comments were received from the public and the hearing was closed at 6:16 PM.

Public Hearing for 1026 Oberkfell Dr. Maryville, IL 62062 opened at 6:16 PM.

The property owner spoke on behalf of the proposed project. The owner is asking for a variance to move the home closer to the property line than what the required minimum stand off distance is required.

General discussions were held by the Planning Commission to discuss the property location. The property developer shared house plans for the site with the public and the Planning Commission.
