### **6:14 PM STAFF REPORTS**

**6:14 PM** Dankenbring presented the October Fire Department report. Mayor asked if anyone had reached out regarding smoke detectors, Dankenbring noted there were some calls.

**6:16 PM** Manley presented the October Police Department report. Manley also reminded all to lock the doors of their vehicles. There have been several auto burglaries in Maryville and the surrounding communities. Manley also reported that the police vehicle that had been declared surplus, sold at Purple Wave auction for \$10,500.

**6:17 PM** Fulton presented the permit and code enforcement report for October. Fulton noted that the structures at 2117 S. Center and 408 Giofre had come down. The Bottle Shop is ready for construction.

**6:20 PM** Hoffmann reported that his department continues to flush hydrants through November.

Clark asked to confirm that the bathrooms would be open for the Turkey Trot. Keplar confirmed. Clark stated that someone had mentioned to her that the bathroom at Parkview was locked. However, Keplar confirmed that bathroom is open all year.

**6:23 PM** Flannery presented her report which was included in the packets. She noted that the bid request for exploratory drilling for the mine subsidence had been rescinded and will be re-done with additional information being included. Flannery also noted that she will be working with the Friends of the Museum on their awarded DCEO grant of \$400,000. Vallino asked who determines what gets done in regards to this grant. Mayor noted the Museum Committee will make recommendation to the Village Board which will have final approval. Mayor noted that the main focus is to make the building more ADA accessible and adding a restroom.

**6:26 PM MAYOR'S COMMENTS**

Mayor White asked for a motion to appoint Pam Hasamear to the Parks & Recreation Committee, term to expire 4/30/2027 (Filling J. Weissert Vacancy)

Mayor White expressed he was very happy that the demolitions of 408 Giofre and 2117 S. Center were completed, noting it was a "team effort". There are a few dead trees on the S. Center property that the owner has agreed to have taken down.

Mayor noted that a press release for the ground breaking ceremony for the Entertainment Pavilion on November 13<sup>th</sup> at 3:00 p.m. in Firemen's Park will be distributed tomorrow.

Mayor noted that this Saturday is the Community Improvement Board's "Adopt a Highway" trash pickup along Vadalabene.

Mayor also noted that the Plaza between Village Hall and the Police building is being worked on and is expected to be completed within the next 2 weeks.
