CAUCUS MEETING MINUTES

6:02 PM Call to Order

Mayor White called the Caucus meeting of Wednesday, November 12, 2025 to order.

6:02 PM Prayer / Pledge of Allegiance

Mayor White opened the meeting with prayer and led the Pledge of Allegiance.

6:03 PM Roll Call.

Trustees Present: Vallino, Bell, Clark, Gulledge, Kukla.

Absent: Schmidt.

Public Comments

There were none.

6:03 PM Minutes – October 22, 2025

Mayor White called for a motion to approve the minutes of the October 22, 2025 Caucus meeting.

Motion to Approve, Moved by Vallino, Seconded by Kukla.

Vote: Motion passed (summary: Yes = 4, No = 0, Abstain = 1).

6:04 PM MS-4 Storm Water Program Review/Presentation – Keplar

Superintendent Keplar presented the annual MS4 report, as mandated by the State. We are required to submit a yearly report to the IEPA outlining the progress made toward meeting the goals in our NOI.

6:09 PM Vacation of Janet Street – Flannery

Administrator Flannery presented a drafted ordinance to vacate Janet Street off Bauer Lane. She explained that four property owners have agreed to cover all costs to maintain the property. The Village will retain an easement through and across all of the affected area. A public hearing on this matter will be held on November 19th.

All were ok to place on agenda for next Board meeting.

6:11 PM Agreement with Collinsville for Wastewater Treatment Services – Flannery

Administrator Flannery presented the final draft of the second amendment to the intergovernmental agreement between the City of Collinsville and the Village of Maryville for water treatment services. She noted that the first amendment was completed in 2008. The new agreement establishes an initial 15-year term, followed by 10-year renewal terms. She stated that there are not many changes, but one update is the removal of the previous flow restriction.

All were ok to place on agenda for next Board meeting.

6:16 PM Social Media Use Policy – Flannery

Administrator Flannery presented the updated Social Media Policy to the Board. She explained that she and legal counsel had reviewed the previously drafted policy, as well as the existing used by the Police and Fire Departments, both of which maintain their own websites and social media pages. A new Section 8 was added to clarify that the Police and Fire Departments are permitted to operate social media accounts, but must remain compliant with the Village's overall policy.

Attorney Genovese noted that the primary concern is maintaining control over what is posted, as well as how comments are handled. She added that it would not be practical for Police and Fire to follow the exact same policy as other departments because their posts often involve crime-related information, safety issues, and other matters unique to their operations.

Mayor White emphasized that having the policy in writing is important to ensure proper oversight and to verify that any information posted under the Village's name is accurate and appropriate.

Trustee Vallino asked what happens if an employee violates the policy. Mayor White responded that violations would be handled as an HR matter. The employee's supervisor would notify Administrator Flannery, and depending on the severity of the violation, the Department Head may address it. If necessary, the issue would be escalated to Administrator Flannery and the Mayor.

Lastly, Mayor White reported that he was contacted by Emma, who oversees governmental affairs for SIUE. On November 20th, from 9:00am-2:00pm., there will be a free food distribution at the Ralph Korte Stadium parking lot on the SIUE campus. They have requested the Village's assistance in helping advertise the event.
