

VILLAGE OF MARYVILLE

UTILITY RATES

Maryville Utility rates are broken down by the following charts for better understanding of your monthly water/sewer billing. Effective August 1, 2023, the following tables outline the calculations used to compute the charges that will appear on your bill, including the minimum rate for each.

INSIDE VILLAGE LIMITS

- (WT) WATER:
\$12.02 minimum for the first 2,000 gallons
\$6.01 per 1,000 gallons over the 2,000 minimum
- (SW) SEWER:
\$15.26 minimum for the first 2,000 gallons
\$7.63 per 1,000 gallons over the 2,000 minimum
- (SO) SOFTNER:
\$1.10 minimum for the first 2,000 gallons
\$0.55 per 1,000 gallons over the 2,000 minimum
- (FC) FACILITY:
\$3.50 flat rate fee per billing cycle (see enclosure)

A MINIMUM BILL FOR A BILILING CYCLE WILL BE \$31.88

OUTSIDE VILLAGE LIMITS

- (WT) WATER:
\$19.26 minimum for the first 2,000 gallons
\$9.63 per 1,000 gallons over the 2,000 minimum
- (SO) SOFTNER:
\$1.50 minimum for the first 2,000 gallons
\$0.75 per 1,000 gallons over the 2,000 minimum
- (FC) FACILITY:
\$4.50 flat rate fee per billing cycle (see enclosure)

A MINIMUM BILL FOR A BILLING CYCLE WILL BE \$25.26
