Village of Maryville Snow and Ice Control Policy April 2, 2025

The policy of the Village of Maryville is to provide snow and ice control on roadway pavements in a safe, timely, and cost-effective manner for its citizens.

1. The Village of Maryville's priority in the event of a snow/ice event will first focus on making all roads accessible for public safety needs. Priority will be given to roadway surfaces serving Village facilities, medical facilities, and school facilities. Subdivision streets are the next priority, with cul-de-sacs a lesser priority. Parks and their parking lots will not be addressed until the completion of the snow/ice event.
2. No parking will be allowed in cul-de-sacs when two (2) or more inches of snow is projected, per Village Ordinance.
3. The focus will be to keep roads passable as the snow/ice event continues.
4. Upon completion of the snow/ice event, the Village will work to widen the passable driving surface. At this time, the Village will focus on making access to mailboxes and intersections more manageable.
5. The Village of Maryville is not responsible for snow in your driveway. The priority is to open the roads and make travel safe for all motorists. There are things you can do to minimize the snow that enters your driveway - clear snow ahead of your driveway, do not shovel snow from your driveway into the road.
6. If you feel that you have an issue with something that has occurred in the snow/ice event you can call and leave a message with the street department superintendent. Please leave a location and a description of the problem. There will not be a returned call .
7. If a plow strikes your mailbox during the snow/ice event, repair your mailbox. Provide photos (if possible), the date the mailbox was struck, your name and address, and a receipt for the repair. Provide these items to Maryville Village Hall with Attention: Street Department on the envelope.
8. If your yard has been damaged by a snowplow, please call the Maryville Street Department at 618-345-7028, ext. 2326, to leave your information. Yard issues will be addressed when the weather allows.
9. The Village of Maryville requests that vehicles not be parked on the street, when possible, during snow and ice events, to allow for more efficient clearing of the roadways.

In the creation of this policy, it must be noted that the motoring public's responsibility by law is to always heed the weather and roadway conditions and make appropriate accommodations for them. No governmental unit has the resources to go beyond a reasonable effort to keep its pavements clear due to seasonal and weather-induced conditions.
